**RESOLUTION NO. GOODS G2025 - 15**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for " SUPPLY AND DELIVERY OF DRUGS AND MEDICINES, DENTAL AND LABORATORY SUPPLIES FOR THE USE OF THE HEALTH SERVICES UNIT OF LGU-IBA" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for twenty-one (21) days dated June 17, 2025 to July 7, 2025;

WHEREAS, in response to the said advertisements, only one bid document was submitted from KAINOMAYAN PHARMACY from NTRA Public Market, Annex Taugtog, Botolan, Zambales. The said bidder paid the bid documents fee and submitted their letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated July 7, 2025;

WHEREAS, upon recommendation of TWG, the bid proposal of KAINOMAYAN PHARMACY was declared Single Calculated Bid for the project "SUPPLY AND DELIVERY OF DRUGS AND MEDICINES, DENTAL AND LABORATORY SUPPLIES FOR THE USE OF THE HEALTH SERVICES UNIT OF LGU-IBA";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds KAINOMAYAN PHARMACY bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring KAINOMAYAN PHARMACY to pass the post-qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."




