BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF SMART TELEVISIONS AND AUDIO-VISUAL EQUIPMENT FOR VARIOUS SCHOOLS IN THE DEPED IBA DISTRICT"
to ANB ENTERPRISES

RESOLUTION NO. GOODS G2025 - 11

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY AND DELIVERY OF SMART TELEVISIONS AND AUDIO-VISUAL EQUIPMENT FOR VARIOUS SCHOOLS IN THE DEPED IBA DISTRICT" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for nine (9) days dated June 9, 2025 to June 17, 2025;

WHEREAS, in response to the said advertisements, only one bid document was submitted from ANB ENTERPRISES from Zone VI, Iba, Zambales. This said bidder paid the bid documents fee and submitted their letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated June 3, 2025;

WHEREAS, upon recommendation of TWG, the bid proposal of ANB ENTERPRISES was declared Single Calculated Bid for the project "SUPPLY AND DELIVERY OF SMART TELEVISIONS AND AUDIO-VISUAL EQUIPMENT FOR VARIOUS SCHOOLS IN THE DEPED IBA DISTRICT";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds ANB ENTERPRISES bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring ANB ENTERPRISES to pass the post-qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- To recommend the AWARD of the Project "SUPPLY AND DELIVERY OF SMART TELEVISIONS AND AUDIO-VISUAL EQUIPMENT FOR VARIOUS SCHOOLS IN THE DEPED IBA DISTRICT" with project identification No. GOODS 2025 - 11 to ANB ENTERPRISES;
- To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






