Ad Posting:

5. A complete set of Bidding Documents may be acquired by interested bidders on **May 19, 2025 to May 29, 2025 4:00 PM** at **Office of Bids and Awards Committee, 3rd Floor, New Municipal Hall, Diritia, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant

to the latest Guidelines issued by the GPPB in the amount of **One Thousand Pesos Only (₱1,000.00)**. The Procuring Entity shall allow the bidder to present its receipt of payment for the bid document fees during the bid-opening schedule of the project.

Pre-Bid:

6. The discretion of the BIDS AND AWARDS COMMITTEE OF THE LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES is to no longer hold a Pre-bid Conference. Justifying this discretion with the Guidelines of the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 Section 22.1, “contracts to be bid with an ABC of less than One Million Pesos (₱1,000,000.00), pre-bid conferences may be conducted at the discretion of the BAC”

Receiving of Bids:

7. Bids must be duly received by the BAC Secretariat through manual submission on or before **May 30, 2025 2:00 P.M.** at the office address **Office of Bids and Awards Committee, 3rd Floor, New Municipal Hall, Dirita, Iba, Zambales.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.

Bid-Opening:

9. Bid opening shall be on **May 30, 2025 2:00 P.M.** at **Office of Bids and Awards Committee, 3rd Floor, New Municipal Hall, Dirita, Iba, Zambales.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
