**INVITATION TO BID FOR:
SUPPLY, DELIVERY, AND INSTALLATION OF MATERIALS FOR
THE EXTENSION OF SECONDARY ELECTRICAL LINE TO THE
MULTI-PURPOSE BUILDING AND MULTI-PURPOSE COMPLEX AT
THE NEW IBA GOVERNMENT CENTER**

- 1) The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through the **GENERAL FUND** intends to apply the sum of **SIX HUNDRED SIX THOUSAND PESOS AND 00/100 (P606,00.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **SUPPLY, DELIVERY, AND INSTALLATION OF MATERIALS FOR THE EXTENSION OF SECONDARY ELECTRICAL LINE TO THE MULTI-PURPOSE BUILDING AND MULTI-PURPOSE COMPLEX AT THE NEW IBA GOVERNMENT CENTER**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **Local Government Unit of Iba** now invites bids for *the above procurement project* Delivery of the Goods is required. Bidders should have completed, at least **5 years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.
 - i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4) Interested Bidders may obtain further information from **Local Government Unit of Iba** and inspect the Bidding Documents at the address given below from **10:00 A.M. to 4:00 P.M.**
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on **January 30, 2026 to February 10, 2026 4:00 PM at Office of Bids and Awards Committee, New Iba Municipal Hall, Dirita, Iba, Zambales** upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (1,000.00)**
- 6) The **Local Government Unit of Iba** will **no longer hold a Pre-Bid Conference**. The discretion rests with the Bids and Awards Committee (BAC), given that for 'contracts to be bid costing less than one million pesos (P1,000,000.00), pre-bid conferences may be conducted at the discretion of the BAC.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through **manual submission** at the Office of the Bids and Awards Committee, **New Iba Municipal Hall, Dirita, Iba, Zambales** on or before **10:00 A.M. February 11, 2026**. Late bids shall not be accepted.

- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on **10:00 A.M. February 11, 2026** at **Office of the Bids and Awards Committee, New Iba Municipal Hall, Dirita, Iba, Zambales**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

- 11) The **Local Government Unit of Iba** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70² of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
