**BAC Resolution Recommending the Award of Project "SUPPLY, DELIVERY, AND
INSTALLATION OF LED WALL FOR USE OF LGU IBA"
to MEDIACAST DIGITAL GROUP INCORPORATED**

RESOLUTION NO. GOODS G2026-02

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY, DELIVERY, AND INSTALLATION OF LED WALL FOR USE OF LGU IBA" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for twenty (20) days dated January 30, 2026 to February 18, 2026;

WHEREAS, in response to the said advertisements, only one bid document was submitted from MEDIACAST DIGITAL GROUP INCORPORATED from 65 M.H. Del Pilar St. Corner Adams, San Antonio, Quezon City. The said bidder paid the bid documents fee and submitted their letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated February 18, 2026;

WHEREAS, upon recommendation of TWG, the bid proposal of M EDIACAST DIGITAL GROUP INCORPORATED was declared Single Calculated Bid for the project "SUPPLY, DELIVERY, AND INSTALLATION OF LED WALL FOR USE OF LGU IBA";

WHEREAS, Section 63.1 of Republic Act No. 12009, the bidder with the LCB, MAB, or the MEAB, in the case of Goods and Infrastructure Projects, or the HRB in the case of Consulting Services shall undergo post – qualification to determine whether the bidder concerned complies with and is responsive to the requirements and conditions as specified in the Bidding Documents;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds MEDIACAST DIGITAL GROUP INCORPORATED bid documents to be substantially complying in the said bidding;


WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring MEDIACAST DIGITAL GROUP INCORPORATED to pass the post-qualification evaluation;

WHEREAS, Section 66.1 of Republic Act No. 12009, the BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated Responsive Bid (LCRB), Highest Rated Responsive Bid (HRRB), Most Economically Advantageous Responsive Bid (MEARB), or Single Calculated Responsive Bid (SCRB), Single Rated Responsive Bid (SRRB) or Single Evaluated Responsive Bid (SERB) as the case may be, after the post-qualification process has been completed"

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


