BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF MATERIALS FOR THE FABRICATION OF 12 UNITS OF FISH-AGGREGATING DEVICES (PAYAO) AND FISHING GEARS FOR QUALIFIED FISHERFOLK ORGANIZATIONS IN IBA, ZAMBALES" to KAE CONSTRUCTION AND SUPPLY

RESOLUTION NO. GOODS G2026-04

WHEREAS, the **LOCAL GOVERNMENT UNIT (LGU) OF IBA** advertised/posted the Invitation to Apply for Eligibility and to Bid for "**SUPPLY AND DELIVERY OF MATERIALS FOR THE FABRICATION OF 12 UNITS OF FISH-AGGREGATING DEVICES (PAYAO) AND FISHING GEARS FOR QUALIFIED FISHERFOLK ORGANIZATIONS IN IBA, ZAMBALES**" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for twenty (20) days dated February 12, 2026 to March 3, 2026;

WHEREAS, in response to the said advertisements, only one bid document was submitted from **KAE CONSTRUCTION AND SUPPLY** from Poblacion St. Candelaria, Zambales. The said bidder paid the bid documents fee and submitted their letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated **March 3, 2026**;

WHEREAS, upon recommendation of TWG, the bid proposal of **KAE CONSTRUCTION AND SUPPLY** was declared Single Calculated Bid for the project "**SUPPLY AND DELIVERY OF MATERIALS FOR THE FABRICATION OF 12 UNITS OF FISH-AGGREGATING DEVICES (PAYAO) AND FISHING GEARS FOR QUALIFIED FISHERFOLK ORGANIZATIONS IN IBA, ZAMBALES**";

WHEREAS, Section 63.1 of Republic Act No. 12009, the bidder with the LCB, MAB, or the MEAB, in the case of Goods and Infrastructure Projects, or the HRB in the case of Consulting Services shall undergo post – qualification to determine whether the bidder concerned complies with and is responsive to the requirements and conditions as specified in the Bidding Documents;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds **KAE CONSTRUCTION AND SUPPLY** bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring **KAE CONSTRUCTION AND SUPPLY** to pass the post-qualification evaluation;

WHEREAS, Section 66.1 of Republic Act No. 12009, the BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated Responsive Bid (LCRB), Highest Rated Responsive Bid (HRRB), Most Economically Advantageous Responsive Bid (MEARB), or Single Calculated Responsive Bid (SCRB), Single Rated Responsive Bid (SRRB) or Single Evaluated Responsive Bid (SERB) as the case may be, after the post-qualification process has been completed"


NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






