**LOCAL GOVERNMENT UNIT OF IBA** a government agency of the Republic of the Philippines, hereinafter called "the Entity":

**ANB ENTERPRISES** a company duly organized and existing under the laws of the Philippines, with principal office at **Zone VI, Iba, Zambales** hereinafter called "the Supplier";

**WHEREAS**, the Entity invited Bids for certain goods and services, particularly **SUPPLY AND DELIVERY OF MODULAR EVACUATION TENT WITH MOSQUITO NET ROOFING FOR USE AT EVACUATION SITES DURING CALAMITIES (GOODS 2026-05)**;

**WHEREAS**, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **ONE MILLION FOUR HUNDRED EIGHTY-FIVE THOUSAND PESOS AND 00/100 (P1,485,000.00)**, hereinafter referred to as the "Contract Price";

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:

- v. Schedule of Requirements;
- vi. Technical Specifications;
- vii. General and Special Conditions of Contract;
- viii. Supplemental Bid Bulletins, if any; and
- ix. Other contract documents that may be required by existing laws and/or the Entity.
