WHEREAS, the Entity invited Bids for certain works, particularly **CONSTRUCTION OF DISASTER-RESILIENT MULTI-PURPOSE MESS HALL WITH CENTRALIZED KITCHEN FACILITY (PHASE 1) (INFRA 2026-02)**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **ONE MILLION THREE HUNDRED FIFTY-TWO THOUSAND THREE HUNDRED FIFTEEN PESOS AND 14/100 (P1,352,315.14)**, hereinafter referred to as the "Contract Price";

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:
