**BAC Resolution Recommending the Award of The Project
"CONCRETING OF GARCIA ST. (PROCESSIONAL ROAD) WITH
REHABILITATION OF LINED CANAL AT BRGY. ZONE 5" to KAEE
CONSTRUCTION SERVICES**

RESOLUTION NO. INFRA I2026-05

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project "CONCRETING OF GARCIA ST. (PROCESSIONAL ROAD) WITH REHABILITATION OF LINED CANAL AT BRGY. ZONE 5 (INFRA 2026-05)" in three (3) conspicuous places within the Municipality of Iba, on the LGU website, and on the PhilGEPS webpage, continuously for twenty (20) days;

WHEREAS, in response to the said advertisements, two bid documents was received from KAEE CONSTRUCTION SERVICES and GMR CONSTRUCTION AND SUPPLY. Both bidders paid the corresponding bid document fee;

WHEREAS, the bid proposal of KAEE CONSTRUCTION SERVICES and GMR CONSTRUCTION AND SUPPLY met the requirements and criteria during the bid opening held on May 13, 2026;

WHEREAS, upon the recommendation of the Technical Working Group (TWG), the bid proposal of KAEE CONSTRUCTION SERVICES was declared Lowest Calculated Bid for the project "CONCRETING OF GARCIA ST. (PROCESSIONAL ROAD) WITH REHABILITATION OF LINED CANAL AT BRGY. ZONE 5 (INFRA 2026-05)";

WHEREAS, Section 63.1 of Republic Act No. 12009, the bidder with the LCB, MAB, or the MEAB, in the case of Goods and Infrastructure Projects, or the HRB in the case of Consulting Services shall undergo post-qualification to determine whether the bidder concerned complies with and is responsive to the requirements and conditions as specified in the Bidding Documents;

WHEREAS, upon post-qualification and evaluation of the bid proposals, the TWG found that KAEE CONSTRUCTION SERVICES substantially complied with the requirements of the said bidding process;

WHEREAS, the Bids and Awards Committee (BAC) approved and adopted the TWG Post-Qualification Report, declaring KAEE CONSTRUCTION SERVICES to have passed the post-qualification evaluation;

WHEREAS, Section 66.1 of Republic Act No. 12009, the BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated Responsive Bid (LCRB), Highest Rated Responsive Bid (HRRB), Most Economically Advantageous Responsive Bid (MEARB), or Single Calculated Responsive Bid (SCRB), Single Rated Responsive Bid (SRRB) or Single Evaluated Responsive Bid (SERB) as the case may be, after the post-qualification process has been completed";


NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- b) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.


