WHEREAS, the Entity invited Bids for certain works, particularly **CONCRETING OF GARCIA ST. (PROCESSIONAL ROAD) WITH REHABILITATION OF LINED CANAL AT BRGY. ZONE 5 (INFRA 2026-05)**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **FOUR MILLION FOUR HUNDRED SEVENTY-SIX THOUSAND EIGHT HUNDRED NINETY-SEVEN PESOS AND 76/100 (P4,476,897.76)**, hereinafter referred to as the "Contract Price";

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

- x. Other contract documents that may be required by existing laws and/or the Entity.
