BAC Resolution Declaring BOTOLAN MUNA FARMERS MULTI-PURPOSE COOPERATIVE (BM FARMERS MPC) to be Technically, Legally and Financially capable supplier and Recommending its Award to the Head of Procuring Entity for the Project "SUPPLY AND DELIVERY OF WELL-MILLED RICE FOR INDIGENT INDIVIDUALS OR FAMILIES IN THE MUNICIPALITY OF IBA"

RESOLUTION NO. NP-SS-2026-01

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA thru DOMITES C. FONTILLAS, Municipal Social Welfare and Development Officer, has submitted a purchase request for the **SUPPLY AND DELIVERY OF WELL-MILLED RICE FOR INDIGENT INDIVIDUALS OR FAMILIES IN THE MUNICIPALITY OF IBA**;

WHEREAS, the Approved Budget for the Contract (ABC) for the above-mentioned project proposal is **FIVE MILLION PESOS AND 00/100 (P5,000,000.00)**

WHEREAS, the HoPE, Hon. Irenca Maniquiz – Binan, signed and approved the proposal and instructed the Bids and Awards Committee, to review the project and ensure that the supplier could undertake the project at terms that are more advantageous to the government;

WHEREAS, the Bids and Awards Committee (BAC) has thoroughly reviewed and evaluated the project proposal and determined that the appropriate mode of procurement is Negotiated Procurement - Sagip Saka (NP-SS) pursuant to Section 11 of Republic Act No. 11321 (Sagip Saka Act of 2019), GPPB Circular No. 02-2025, and Section 75 of Republic Act No. 12009 (New Government Procurement Act or NGPA), allowing direct purchase of agricultural products from capable and registered suppliers;

WHEREAS, Hon. Irenca Maniquiz – Binan approved the recommendation of the Bids and Awards Committee for the use of Negotiated Procurement - Sagip Saka (NP-SS) for this procurement;

WHEREAS, the Bids and Awards Committee forwarded the Request for Quotation (RFQ) and Terms of Reference prepared by the End-user to **BOTOLAN MUNA FARMERS MULTI-PURPOSE COOPERATIVE (BM FARMERS MPC)**, being a potential supplier who has the necessary credentials and is deemed to be technically, legally, and financially capable of taking on the project;

WHEREAS, the price quotation submitted by the supplier was opened and evaluated as follows:

WHEREAS, the proposal of **BOTOLAN MUNA FARMERS MULTI-PURPOSE COOPERATIVE (BM FARMERS MPC)** with office address located at Tampo(Pob), Botolan, Zambales, met all the technical specifications and conformed to the Terms of Reference prepared by the End-user for the project **"SUPPLY AND DELIVERY OF WELL-MILLED RICE FOR INDIGENT INDIVIDUALS OR FAMILIES IN THE MUNICIPALITY OF IBA"**;

WHEREAS, based on the price evaluation and benchmarking against prevailing farm-gate and local market prices, the BAC found the offer of **BOTOLAN MUNA FARMERS MULTI-PURPOSE COOPERATIVE (BM FARMERS MPC)** to be fair, reasonable, and highly advantageous to the government, and the BAC has agreed to adopt such findings;

WHEREAS, the verification and evaluation of all submitted legal and technical documents show that **BOTOLAN MUNA FARMERS MULTI-PURPOSE COOPERATIVE (BM FARMERS MPC)** meets all the requirements of LGU - Iba and its price quotation does not exceed the ABC;

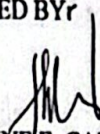


NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

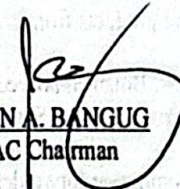

- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.

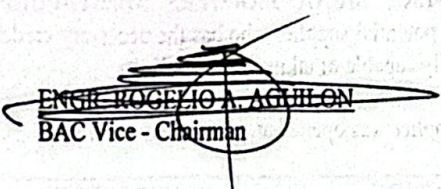
