This CONTRACT executed on the _____ day of JUL 01 2026 by and between:

LOCAL GOVERNMENT UNIT OF IBA a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

KAINOMAYAN PHARMACY a company duly organized and existing under the laws of the Philippines, with principal office at NTRA Public Market, Annex Taugtug, Botolan, Zambales hereinafter called "the Supplier";

WHEREAS, the Entity invited Bids for certain goods and services, particularly **SUPPLY AND DELIVERY OF DRUGS AND MEDICINES AND LABORATORY SUPPLIES FOR USE OF HEALTH SERVICES UNIT OF LGU-IBA, ZAMBALES (GOODS 2026-09)**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **THREE MILLION FIFTY-ONE THOUSAND ONE HUNDRED NINETY-FOUR PESOS AND 00/100 (P3,051,194.00)**, hereinafter referred to as the "Contract Price;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

In consideration of the Contract Price of **THREE MILLION FIFTY-ONE THOUSAND ONE HUNDRED NINETY-FOUR PESOS AND 00/100 (P3,051,194.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the Supplier agrees to deliver and perform the items and related services for the **SUPPLY AND DELIVERY OF DRUGS AND MEDICINES AND LABORATORY SUPPLIES FOR USE OF HEALTH SERVICES UNIT**



OF LGU-IBA, ZAMBALES described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4. The LOCAL GOVERNMENT UNIT OF IBA agrees to pay the above-mentioned sum to the Supplier in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
