CONTRACT AGREEMENT
(Negotiated Procurement - Sagip Saka / NP-SS)

KNOW ALL MEN BY THESE PRESENTS:

This Contract Agreement is entered into this 29th day of June, 2026, in Iba, Zambales, Philippines, by and between:

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, a local government unit organized under the laws of the Republic of the Philippines, represented herein by **HON. IRENEA MANQUIZ - BINAN**, Municipal Mayor, hereinafter referred to as the "**PROCURING ENTITY**";

And

BOTOLAN MUNA FARMERS MULTI-PURPOSE COOPERATIVE (BM FARMERS MPC), a duly registered Farmers and Fisherfolk Cooperative/Enterprise (FFCE), represented herein by its Authorized Representative, **ROMUALDO P. RAMOS**, hereinafter referred to as the "**SUPPLIER**".

WITNESSETH:

WHEREAS, the Procuring Entity requires the Supply and Delivery of Well-Milled Rice for Indigent Individual Families in the Municipality of Iba under Purchase Request No. 26-101-090-02-005-027;

WHEREAS, the Bids and Awards Committee (BAC) approved the resort to Negotiated Procurement - Sagip Saka (NP-SS) pursuant to Republic Act No. 11321 (Sagip Saka Act), GPPB Circular No. 02-2025, and Republic Act No. 12009 (New Government Procurement Act);

WHEREAS, the Supplier warrants that it is a validly accredited agricultural enterprise under the DA-FFEDIS registry (or alternate recognized DA registries) whose approved commodity line directly covers the production, milling, and trading of cereals and grains;

WHEREAS, the Procuring Entity has accepted the Supplier's final offer for the execution and completion of this project in the total contract amount of **FOUR MILLION NINE HUNDRED EIGHTY-THREE THOUSAND SIX HUNDRED NINETY-SIX PESOS AND 00/100 CENTAVOS ONLY (₱4,983,696.00)**, inclusive of all applicable government taxes, customized packaging, and delivery fees;

NOW, THEREFORE, the parties agree as follows:

1. CONTRACT DOCUMENTS & ORDER OF PRECEDENCE

The following documents shall form an integral part of this Contract:

- a) Technical Specifications and Delivery Schedule;
- b) Supplier's Written Proposal/Offer Form and Price Schedule;
- c) FFEDIS Certificate of Registration (or alternate authorized DA-registry proof);
- d) Omnibus Sworn Statement (OSS) for Sagip Saka; and
- e) Notice of Award (NOA) and Notice to Proceed (NTP).

2. COMMODITY SCOPE AND DELIVERY TERMS

- 2.1 The Supplier shall fulfill the project "Supply and Delivery of Well-Milled Rice for Indigent Individual Families in the Municipality of Iba" strictly matching the quantities, technical requirements, and unit costs specified in the individual Purchase Order (PO).
- 2.2 Delivery Schedule Alignment: All deliveries to be executed under this contract shall be made in strict accordance and consistent with the Delivery Schedule specified in the procurement documents and the Notice to Proceed (NTP).
- 2.3 The contract price includes all custom packaging, printing, hauling, loading/unloading, logistics, and all applicable government taxes.

3. TECHNICAL SPECIFICATIONS & QUALITY ASSURANCE FOR RICE

The rice delivered under this agreement must comply with the minimum statutory standards:

- 3.1 Rice Grade: Must be local well-milled rice, suitable for human consumption, and free from live insects, molds, stones, or abnormal odors.
- 3.2 Packaging Requirements: All deliveries must be packed in durable, clean, and new woven polypropylene bags weighing exactly 10.0 kg net per sack.
- 3.3 Packaging Requirements: Each sack shall have a "Bagong Pilipinas" logo printed on it.

4. ANTI-MIDDLEMAN & VALID REGISTRATION WARRANTY

- 4.1 The Supplier expressly warrants that all rice delivered was directly cultivated, harvested, and milled by its own registered members.
- 4.2 Trading commercial, imported, or third-party brokered supply lines under this agreement is strictly prohibited and constitutes a material breach.
- 4.3 The Supplier warrants its DA registry status remains active throughout the contract lifecycle. Any suspension or cancellation on the FFEDIS portal shall serve as immediate ground for contract termination.

5. PRICING REASONABLENESS & PENALTIES

- 5.1 The contract unit pricing is certified as reasonable, matching or outperforming the monitored farmgate price indices validated by the Department of Agriculture (DA).
- 5.2 Liquidated Damages: If the Supplier fails to deliver within the specified period, a penalty of one-tenth of one percent (0.001) of the cost of the unperformed portion shall be deducted for every day of delay. Once the cumulative penalty reaches ten percent (10%), the Procuring Entity may rescind the contract without prejudice to other courses of action.
