AMENDING ORDINANCE NO. 018-008, SERIES OF 2008 TITLED: AN ORDINANCE PROVIDING FOR THE SHARING SCHEME FROM PAYMENT OF PENALTIES OF VIOLATORS OF MUNICIPAL ORDINANCES OF IBA, ZAMBALES, TO INCREASE THE ALLOCATED SHARE OF BARANGAY ENFORCEMENT UNITS ON THE AMOUNT OF PENALTY COLLECTED FROM VIOLATION OF ORDINANCES

Be it ordained by the Sangguniang Bayan of Iba, Zambales.

SECTION 1. This Ordinance shall be known as Ordinance Amending Ordinance No. 018-008, Series of 2008 Titled: An Ordinance Providing for the sharing scheme from payment of penalties of violators of Municipal Ordinances of Iba, Zambales, to increase the allocated share of Barangay Enforcement Units on the amount of Penalty collected from violation of ordinances.

SECTION 2. Declaration of Policy - It shall be the policy of the Municipal Government of Iba, Zambales to ensure the effective and efficient enforcement

of all Municipal Ordinances enacted by the Sangguniang Bayan by encouraging the participation of all Barangay Government Units in enforcing Municipal Ordinances of Iba, Zambales.

SECTION 3. As a frontline political unit, a barangay plays a crucial role in the effective and efficient enforcement of Municipal Ordinances to ensure the general welfare of the inhabitants. For this purpose, a sharing scheme is hereby established where a Barangay Government Unit shall be given 75% share from payment of penalties of offenders/violators of Municipal Ordinances that it had enforced in the barangay.

SECTION 4. The 75% share of each barangay shall be released quarterly by the Municipal Treasurer's Office directly to each barangay government unit. The use of the proceeds shall be determined by the concerned Sangguniang Barangay.

SECTION 5. All other ordinances inconsistent with the provisions of this Ordinance are hereby repealed and modified accordingly.

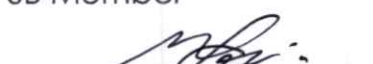
SECTION 6. This Ordinance shall take effect immediately upon its approval and compliance with the mandated posting requirements under the Local Government Code.

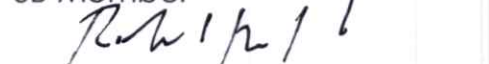
