ANB ENTERPRISES a company duly organized and existing under the laws of the Philippines, with principal office at **Zone VI, Iba, Zambales** hereinafter called "the Supplier";

WHEREAS, the Entity invited Bids for certain goods and services, particularly **SUPPLY AND DELIVERY OF OFFICE FURNITURE AND FIXTURES FOR VARIOUS OFFICES AT THE NEW IBA MUNICIPAL HALL (GOODS 2026-14)**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **ONE MILLION FORTY-SIX THOUSAND SEVEN HUNDRED SIXTY PESOS AND 00/100 (P1,046,760.00)**, hereinafter referred to as the "Contract Price;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

- iv. Bid Data Sheet;
- v. Schedule of Requirements;
- vi. Technical Specifications;
- vii. General and Special Conditions of Contract;
- viii. Supplemental Bid Bulletins, if any; and
- ix. Other contract documents that may be required by existing laws and/or the Entity.

4. The **LOCAL GOVERNMENT UNIT OF IBA** agrees to pay the above-mentioned sum to the Supplier in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).

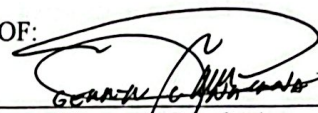
