- 1) The **Local Government Unit of Iba, Zambales**, through the **20% Development Fund and 2026 Annual Budget per Ordinance No. 13-12 Series of 2025 and Engineering Office/Capital Outlay/Buildings of Supplemental Budget No. 1 per Ordinance No. 13-12 s. 2026**, intends to apply the sum as reflected hereunder, being the Approved Budget for the Contract (ABC) to payments under the contract for **each lot**:

Completion of the Works is required **for each lot**. Bidders should have completed, within **5 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB)

- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4) Interested bidders may obtain further information from **Local Government Unit of Iba, Zambales** and inspect the Bidding Documents at the address given below from **9:00 AM to 4:00 PM**.

- 5) A complete set of Bidding Documents may be acquired by interested bidders on **July 1, 2026 to July 16, 2026 4:00 PM** at **Office of Bids and Awards Committee, New Iba**

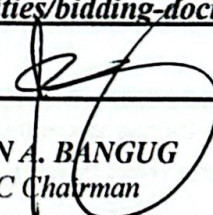
Municipal Hall, Dirita, Iba, Zambales and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of Ten Thousand Pesos Only (P10,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The **Local Government Unit of Iba, Zambales** will hold a **Pre-Bid Conference** on **July 8, 2026 2:00 PM at Office of Bids and Awards Committee, New Iba Municipal Hall, Dirita, Iba, Zambales**, which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through **manual submission** at the address indicated below on or before **July 20, 2026 2:00 P.M. at the Office of Bids and Awards Committee, New Iba Municipal Hall, Dirita, Iba, Zambales**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9) Bid opening shall be on **July 20, 2026 2:00 P.M. at Office of Bids and Awards Committee, New Iba, Municipal Hall, Dirita, Iba, Zambales**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
